Freedom of all persons to move to a foreign country and to divest themselves of their nationality shall not be violated. Given these circumstances, some have viewed Article 9 as increasingly irrelevant. Article 99 binds the Emperor and public officials to observe the constitution. Article 99 of the Constitution of Japan provides that the constitution takes precedence. A bill becomes a law on passage by both Houses, except as otherwise provided by the Constitution. Prime Minister Shinzo Abe says his Liberal Democratic Party should accelerate work on developing a plan to amend the Constitution so it can be submitted to the Diet in autumn. Every person shall have the right of peaceful petition for the redress of damage, for the removal of officials, for the enactment, repeal or amendment of laws, ordinances or regulations and for other matters; nor shall any person be in any way discriminated against for sponsoring such a petition. Other opposition groups entered symbolic censure motions against Mr. Each constitution starts with an imperial edict made by the Emperor.
